NOTIFICATION

on violation of the order of dissemination of information record ID: 584588-HB

In accordance to the request of the Prosecutor General of the Russian Federation or his deputy, we notify you of taking measures to restrict access to information resources following 29.06.2022 № 27-31-2022/Tpe6788-22:

The procedure for restricting access to information:

Roskomnadzor, on the basis of the specified request of the Prosecutor General of the Russian Federation or his deputy, *immediately* sends a request to telecom operators providing services to access the Internet (hereinafter - telecom operator) to take measures to restrict access to the information resource on which lawbreaking information is posted.

The telecom operator is obliged to restrict access to the information resource, which contains information disseminated in violation of the law, *immediately* after receiving a request from Roskomnadzor.

The procedure for responding to this notification:

3. The hosting provider or another person is obliged:

immediately after receiving this notice, inform the owner of the information resource about the need to immediately delete the information disseminated in violation of the law;

in case of refusal or inaction of the owner of the information resource to delete the information disseminated in violation of the law, *after 24 hours* from the date of receipt of this notification, restrict access to the specified information resource.

4. The owner of the information resource is obliged:

delete information disseminated in violation of the law *within 24 hours* from the date of receipt of the relevant notification from the hosting provider or another person.

The procedure after eliminating the violation:

If the owner of an information resource has deleted information distributed in violation of the law, he must send notification about this to the Roskomnadzor email address <u>398-fz@rkn.gov.ru</u>, indicating the record identifier in the subject line: **584588-HB**.

After Roskomnadzor checks the accuracy of the information specified in the notification, and upon confirmation of the fact that the violation has been eliminated, access to the information resource is resumed on the territory of the Russian Federation by telecom operators, if it was previously limited.

Additional Information:

The above procedure for taking measures to restrict access to information disseminated in violation of the law is provided for in the Article 15.3 of the Federal Law N 149-FZ dated Jul 27, 2006 'On Information, Information Technologies and Protection of Information'.
